## July 10, 2024 Meeting Board of Directors

The Board of Directors of the Comal Appraisal District met at the appraisal district office at 900 S. Seguin Avenue, New Braunfels, Texas.

Booker, Tanner Jones, Ryan Dow, Pam Krause, Matthew Tepper, John Cox, Richard Tobias, Camille Adams, Dave Hindman, Douglas Kirk, Michael Maurer, Barbara Monig (sp?) and companion, Margot Brown and children (JR, Ryan and Reece) and Michelle Klecan.

Mr. Tyler called the meeting to order at 12:05 p.m. stating that this meeting is being held in open session in accordance with Chapter 551 of the Texas Government Code and business as conducted by the Board will be done so in open session.

### **1 - ADMINISTER OATH OF OFFICE**

Judge Sherman Krause issued the Oath of Office to the three newly elected directors. Mr. Tyler thanked Judge Krause for taking the time to come to our meeting to administer the oath.

### **2 - CITIZENS COMMUNICATIONS**

Mr. Douglas Kirk addressed the Board in regard to not having received a settlement check. He stated that he sued the CAD five years ago and settled in November 2023 and has yet to receive his payment. He has concerns that other lawsuits may have been settled and not received their compensation. He wants to know how long it will take to have this resolved so he does not have to take legal action.

Mr. Michael Maurer addressed the Board to congratulate the newly elected/sworn in directors. He stated that he would like to see half of the people on the Board be elected by the people that they represent.

### **3 - TAX CODE SECTION 6.15 COMMUNICATION**

Mr. Tyler explained Tax Code section 6.15 to the new directors. The purpose of this section is to provide an open forum to share with the board anything that a community member has approached a board member with, such as questions about values or feedback for Mr. Booker. These items must be discussed in an open session.

Mr. Couch presented concerns about difficulty accessing the protest portal. Mr. Miller suggested that we put a blurb on our website sharing which internet browsers make it easier to use the portal.

Mr. Miller shared that one of his employees had a very positive experience with Jim during their ARB informal meeting this morning.

Mr. Couch said that he had a disabled vet also share his positive experience with the CAD staff.

Mrs. Hoyt said her husband also had a positive experience with Tersea in commercial.


